## Terms and condition

1. The "prize draw" is open to people aged 18 and over who provide their email address on the "Feedback form" after each screening.
2. Purchasing a cinema ticket is necessary. You may purchase more than one ticket, but you can only submit one feedback form.
3. Employees of SERET International ("SERET Int.") or their associated team, or anyone else connected with the Prize Draw may not enter the Prize Draw.
4. Entrants into the Prize Draw shall be deemed to have accepted these Terms and Conditions.
5. By submitting your personal information, you agree to receive emails from SERET Int. containing offers. You will be given the opportunity to unsubscribe on every email that we send.
6. To enter the Prize Draw you must complete the Feedback form and submit your name and email address. 9. The closing period of the Prize Draw is between 19:30 on 6 May 2018, and 20:00 on 7 May 2018. Entries received outside this time period will not be considered.
10. One winner will be chosen from a random draw of entries received in accordance with these Terms and Conditions. The draw will be performed by a random hand pick up process. The draw will take place on 8 May 2018.
11. The winner will receive return tickets for two to Israel, courtesy of Israir Airlines & Tourism, operating direct flights to Edinburgh.
12. SERET Int. accepts no responsibility for any costs associated with the prize and not specifically included in the prize (including, without limitation, travel to and from the cinema).
13. The winner will be notified by email on or before 18 May 2018. If a winner does not respond to SERET Int. within 14 days of being notified by SERET Int., then the winner's prize will be forfeited and SERET Int. shall be entitled to select another winner in accordance with the process described above (and that winner will have to respond to notification of their win within 14 days or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited and SERET Int. shall be entitled to select another winner.
